The DAAD-Stiftung was established on May 5, 1999. It is an unincorporated, independent foundation operating under the trusteeship of the German Academic Exchange Service (DAAD) e.V. The Foundation Board works with the coordination office to provide a way for DAAD alumni and friends, as well as everyone interested in global exchange, to support academic education and research outside the context of publicly funded programs.

What we do

The DAAD-Stiftung is committed to advancing a charitable purpose, namely supporting worldwide academic and artistic exchange and promoting international higher education cooperation. Every contribution counts.

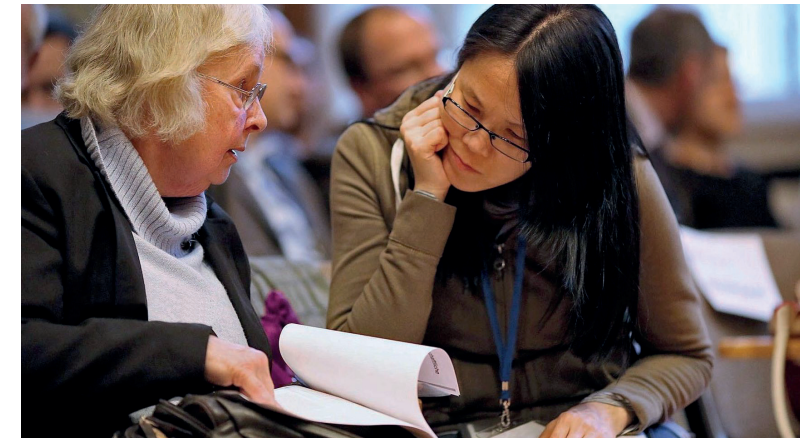
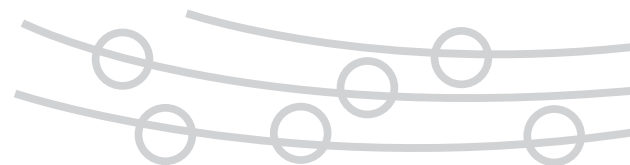
The DAAD-Stiftung currently focuses on two primary project/funding lines:

Scholarship Sponsoring

You can sponsor a scholarship or a project, either individually, as a group or as an institution. The DAAD-Stiftung provides a range of funding options in this area, such as:

- a summer school scholarship (starting at € 2,000)
- a semester scholarship (starting at € 10,000)
- a full-year scholarship (starting at € 20,000)

How you define the parameters of your scholarship or funding project (e.g., subject area, country of origin, gender) is essentially up to you. Depending on the type of your donation and the purpose of the funding, your project may bear a name of your choosing.
